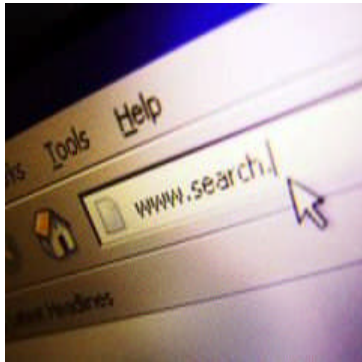

AccessAll Participant Agreement
AT&T Yahoo! High Speed Internet

The One Economy Corporation, a non-profit dedicated to bringing technology and its benefits into homes throughout the country, has identified you as a candidate for the AT&T AccessAll program. As part of the program, AT&T Internet Services will provide AT&T Yahoo! High Speed Internet Express (where available) to participants for approximately two years. Participants will receive payment coupons to pay the advertised monthly rate for the high-speed Internet service, and will only be responsible for payment of the Federal Universal Service Fee, taxes and surcharges. **Participants must have local telephone service from AT&T to receive the high-speed Internet offer.** This could include AT&T's Lifeline Service, which provides local telephone service to qualified applicants at discounted rates. To inquire about Lifeline Service, please follow steps outlined on AT&T AccessAll website. If at anytime during two years a participant moves from the qualifying home or services interrupted due to delinquent payments they will not be eligible to continue with free Internet service anymore. At the end of the two-year program period, participants may continue to utilize AT&T Yahoo! High Speed Internet Express at the then-current monthly rates.

Yes, I want two years of AT&T Yahoo! High Speed Internet. I understand that I am responsible for payment of the Federal Universal Service Fee and other taxes and surcharges on a monthly basis and that I must also subscribe to local telephone service from AT&T. I further understand that if I wish to continue the service after the program's initial two-year period, I will be responsible for paying the then-current monthly charges for AT&T Yahoo! High Speed Internet Express. If I don't contact AT&T Internet Services at 866-722-YAHOO at least three (3) days prior to the end of the program period, my Internet service will automatically continue and I will be responsible for the then current rate. I agree to follow AT&T's Terms of Services, Privacy Policy and Acceptable Use Policy as set forth at www.sbc.yahoo.com. I understand that these policies may be amended from time to time and I should check the website for any updates.
